### Free Platform Fees for 6 Months Promotion

#### 1. General

- 1.1. Details contained within advertisements for this promotion form part of the promotion's conditions.

- 1.6. This promotion only applies to chargers connected on a Charge Point Operator (CPO) Charging Plan that includes Platform Fees.

#### 2. Eligibility

- 2.1. Only eligible entrants can participate in this promotion.
- 2.2. An eligible entrant is a person who:
  - 2.2.1. is a resident of Australia;
  - 2.2.2. is 18 years of age or older;
